- Wage statements Form(s) W-2
- Pension and Social Security
   Statements- Form(s) 1099R and SSA-1099
- All 2016 informational statements, including:
  - Interest and dividends statements—Form(s)
     1099INT and 1099DIV
  - Mortgage interest statements—Form(s) 1098
  - Tuition payments statements—Form(s) 1098T
  - ACA Marketplace statementform 1095A
  - Copy of last year's tax return, if available

- Info on all other deductions/ credits (include charitable contributions or employee business expenses)
- If homestead credit is claimed:
  - A completed rent certificate and/or copy of your 2016 property tax bill
  - A printout of any Wisconsin
     Works (W2) payments
     received in 2016
- A record of any estimated tax payments made for the 2016 tax year
- If direct deposit of your refund is desired, a voided check for a checking account or a deposit slip for a savings account
